

food waste is limited, and food resources are distributed to those who need them.

Our role as an incubator, facilitator, training provider, and services hub has fortified community groups and organisations, enabling them to thrive.

Our Team's Evolution: The ANCAD team - comprising board members, employees, contractors, volunteers, consultants, and advisors - has been instrumental in executing our mission. This year witnessed a dynamic shift with seasoned staff embarking on new communityfocused ventures and new staff members infusing our kaupapa with fresh perspectives and a commitment to our values. We salute the unwavering professionalism and dedication of our team.

Strategic Collaborations and Initiatives: Our strategic intent

has been shaped by meaningful whakawhanaungatanga with funders, community representatives, and government entities. We've launched pioneering initiatives, such as dedicated support for Pacific peoples' organisations, expanded drop-in sessions across Tāmaki Makaurau, and innovative workshop programmes. We've strengthened ties with Māori, Pacific, Chinese, and ethnic communities, offering support and facilitating critical conversations. We have provided customised consultancy and support to many organisations.

Governance and Compliance:
The evolving landscape of board management and compliance, highlighted by new legislation, has underscored the importance of mana whakahaere. ANCAD is poised to propose rules amendments at the upcoming AGM, reflecting our commitment to governance excellence.
Our well-attended governance courses are a testament to the community's trust in our expertise. We've navigated a changing economic environment,

shifting funder priorities and maintained fiscal stability and financial performance over the last twelve months.

In addition, we request a letter of support or acknowledgement for any substantial consultancy support offered. From time to time, we invite external organisations to conduct an independent evaluation (funds permitting) to gain insights into our programmes and services. We also maintain records of all engagements for reporting purposes.

ANCAD's LiiFT Aotearoa professional development programme is designed to see community and small to medium sized for-purpose (NFP) groups LiiFTed and strengthened through the offering of relevant and affordable capability-building courses, presented by top, professional consultants and facilitators.

The key topics this year have centred around governance and management, funding and fundraising (including our ever popular 'Strategic grant seeking and writing' in-person workshops) numerous topics for leadership, social media, first aid and a series focussed on volunteer management.



We have also taken our 'Role of the Treasurer' workshop to meet the needs of groups in West and South Auckland and our free monthly 'Governance Matters' sessions on Zoom, that addresses specific topics on the principles of governance, has had numerous people connect in from all of the country, from Kaitaia to Invercargill, and everywhere in between.

We were also able to organise a

special governance workshop to be held at Aotea, Great Barrier Island, through funding support from their local board.

At the time of the celebration of Matariki and the Māori new year, we put on a popular workshop 'Building partnership with Māori: A Matariki perspective'. Those who attended appreciated the opportunity to network and hear and learn from others on their life journey and gained a greater understanding of how to implement principles of growth back into their own organisations.

During 2023 we initiated a free, new monthly series called 'A lunchtime LiiFT' that enabled people to attend a 45-minute session during the hundreds of people register and attend. Funders also kindly fielded questions from attendees.

In 2024, thanks to funding support from the Devonport-Takapuna Local Board, the Hibiscus and Bays Local Board, and the Kaipātiki Local Board, we were able to offer and bring several key workshops and Zoom sessions to not for profit groups in these two local board areas. We were also able to offer free 'Ask the Experts' drop in-sessions for anyone in these areas who wanted to come and meet our experts and ask them a question about matters to do with governance and management, funding and fundraising, finances and accounting.



lunch hour on topics of interest and importance to not for profit organisations. Such topics included 'Al in the workplace: Risks and opportunities". Another was 'What a community social researcher does'.

Our two Funding Fairs, held via Zoom webinar, that saw different funders present for about 20 minutes on how to apply to them for funding and what they are looking for with applications, saw



We have assisted partner organisations and sought to strengthen and support leadership, boards, trustees, committee members and teams, both locally and across Auckland and New Zealand, to be adaptive and become resilient in a changing environment.

The demand and need from the not for profit community has remained constant and has



increased over last year (which was a record year of delivery). We were able to deliver 47 sessions and workshops, including in-person and online. We had received 2905 registrations for these sessions, which is more than double the previous year's total, establishing another record year of support.

We are very grateful for the funding support from The Tindall Foundation, Foundation North and Four Winds and also the Devonport-Takapuna Local Board and Hibiscus Bays Local Board.

Attendees to the training have always given high praise of both the content and the quality of the presenters. Our special thanks go to all of the LiiFT presenters who have made themselves available to build the capability of not for profit organisations and community groups.





LiiFT impact story Meadowood Community Centre

Meadowood Community Centre is based in Unsworth Heights on Auckland's North Shore. We are a charitable, not for profit organisation. I manage the community centre to provide community driven activities and forums that connect and empower our community. I have attended several ANCAD LiiFT Aotearoa training sessions with the most notable ones for me being: Governance and Health and Safety Responsibilities of Boards, and also Grant Seeking and Writing workshops.

Being new to the centre manager role, I appreciated the insights gained from the Governance sessions. I fed back the information to my board and it helped to lift our governance understanding and hasten us to review Health and Safety policies.

The workshop on grant applications has been so valuable because it has changed how I apply for funding. Post the course, my grant applications are better prepared, the budget section more professional and my responses to the application questions are more succinct. I feel better equipped in my role now.

The training sessions provided by ANCAD have also been a great way for me to network with other community organisations out there. I have stayed in touch with a few of the people that I've met on these courses and we swap notes, collaborate on new projects, support one another and share information.

Without the courses that ANCAD offer, and Simon's friendly, approachable and helpful manner, I would feel more isolated, less equipped and less confident in my role.



COMMUNITY ACCOUNTING

The Community Accounting programme is a collaborative partnership between Auckland North Community and Development (ANCAD) Massey University and Chartered Accountants Australia and New Zealand (CA ANZ).

This service is for small community groups, including charitable trusts, incorporated societies and registered charities within (as well as outside) the Auckland Region, who require accounting assistance.

I wish to thank you and your team for your recent efforts to assist us in our start-up endeavours while we establish our banking and accounting processes. We found the Community Accounting Aotearoa Programme easy to access and extremely flexible in its delivery – something that was important to us since we needed to accommodate the schedules of 2 board members. Our Chairperson and I found the sessions were specifically tailored to our needs and we appreciate that a check was made of our understanding after each one. Lastly, because we are ourselves a startup charity, it was important to us that the programme was fee-free.

Community Accounting Impact story | Te Wana Trust

Te Wana's charitable purpose is to encourage, foster and provide continuous quality improvement programmes and solutions for community primary health, mental health, and the wider tangata whenua, community and voluntary sector, so that they may be the finest they can be, in the best interests of the communities they serve.

Te Wana approached ANCAD's CAA Lead, Geoff Andrews, after reading about the free and confidential programme for small and medium charities.

The Trust were looking for assistance with preparing their 2023 Performance Report.

The student team (with support from their CA mentor) reviewed the 2022 reports and format, reconciled the cash and credit from XERO to bank statements and checked the General Ledger accounts balance.

The 2023 financial reports were prepared and made available for submission

In addition, the students made recommendations to the Trust for areas of improvement and created templates for the Trust to self-manage future financial reporting.

ANCAD acknowledges the dedication and commitment of Geoff Andrews, as Community Accounting Programme Lead over the years, prior to his leaving ANCAD, in 2023.

Community Accounting Impact story |

Migraine Foundation Aotearoa New Zealand Incorporated

The Migraine Foundation's charitable purpose is to benefit the community by promoting awareness of migraine, and its impact and treatments, to reduce the health, economic and social burden of migraine.

The Foundation approached ANCAD for assistance with implementing the XERO accounting platform, including designing a customised chart of accounts, verifying and reconciling past transactions and events and matching past transactions with supporting documentation.

The student team (with support from their CA mentor) also evaluated risk factors and assisted with developing risk management policies and procedures and offered guidance and recommendations concerning the charity's accounting management.

I am blown away by the dedication, time and knowledge the team, led by Glen, have volunteered. From having no system, no way of accounting for grants and funds, we are now legitimately running our accounts in Xero and we have data and reports to report back to our funders and donors. We are writing to express our gratitude for the support the Trust received from the Community Accounting Aotearoa Programme. With support from ANCAD and the wider team, the Vaimoso Charitable Trust completed their application on time. This support ensured a well-prepared submission, setting them up for future success.

ANCAD helped the Nauru Community establish a charitable trust to enhance cultural, social, and economic well-being.

The Nauru Community aimed to create a charitable trust but faced legal challenges.

ANCAD's Pacific People's
Capability Lead, Clark Tuagalu
provided support, ensuring
documents were reviewed
and concerns addressed. Clark
arranged consultations for the
Nauru Community with experts
Stephanie Maitland (Maitland
and Associates), Fiona Brennan
(ANCAD General Manager) and
Glen Hill (ANCAD accountant)
who offered valuable insights.
With Clark's support, the trust
deeds were finalised.

The next step for the Nauru Community is to apply for incorporation and a charitable trust status, solidifying their foundation for future goals.

The Nauru Community's journey highlights the power of dedicated support.

Consultancy Impact Story | Drama New Zealand

Drama New Zealand reached out to ANCAD to organise a workshop for them to upskill their National Executive members in their governance role as well as delivering a workshop on integrating tikanga Māori and a bicultural approach to their working environment.

Drama New Zealand is an all-volunteer-led Incorporated Society of Drama teachers in Aotearoa. Drama teachers don't have a lot of time to give, especially since they already volunteer huge chunks of time creating theatre at their schools. But the individuals on the National Executive are an extraordinary group of dedicated people. As an Association, they look to serve the needs of their members, provide professional development opportunities, advocacy, teaching resources, and lots more.

Since everyone is a volunteer, few have any real training in governance, accounting practice, or fundraising. They wanted to onboard the next set of volunteers who put up their hands and to invest in their team.

The team is spread all over Aotearoa with two in Christchurch, three in Auckland, one in Palmerston North, one in Alexandra, and one in Gisborne.

Drama New Zealand is very much wanting to be fully bicultural.
They wanted to integrate tikanga into their print and online collateral and to ensure that they are inclusive in their public meetings and resources. But more than that, they wanted biculturalism to be at the heart of the Association.

We organised for presenter Hilary Star Foged (LEAD) to work with Drama New Zealand, focussing on 'Building partnership with Māori based on Te Tiriti', who said afterward that this was an awesome group to work with.

Drama New Zealand returned the compliment and said "The workshop with Hilary was just what we needed - the talk that I had with Hilary before hand was essential and it was clear Hilary knew about us as a team and had done her homework. We had lots to talk on afterwards and she had some great thought-provoking questions and challenges for us moving forward." (Annette Thomson, President, Drama New Zealand)

Since this workshop with ANCAD a year ago, here are some initiatives that Drama New Zealand have put in place, says Annette:

- Monthly meetings run with karakia before and after.
- An updated logo to reflect the bicultural nature of the constitution.

- Changed our constitution from honour to 'give effect' to Te
- One of our three priorities in our strategic plan is to give effect to Te Tiriti.
- Held a Mātuaranga Māori focussed conference, Ka Mua Ka Muri, in Rotorua, with Māori keynote speakers and the workshops had a Māori focus.
- Our conference this year is a joint one with Australia, called Kia Tonui.
- We have seconded a Māori kaiako onto our executive.
- We held a hui for Māori teachers in Auckland (but they came for free from over the whole country) run by Mana Inc.
- We produced Māori-focussed resources for kaiako to use.
- We run Tikanga specific webinars for kaiako.

Annette says, "Our future endeavours regarding Drama New Zealand's continued focus to give effect to Te Tiriti, in our association include:

- Changing our name to Whakaari Aotearoa Drama NZ in the constitution.
- Developing further networks for Māori teachers.
- To update the logo and branding to better reflect an Aotearoa identity.
- To develop further resources for kaiako to use on Mātauranga Māori."

Consultancy impact story **GI Eagles Basketball Trust**

Although ANCAD supports many societies through the Community Accounting programme, we find that some of those clients need a degree of support with specific issues arising after the end of the project.

During the year, we assisted Esther Ducai of the Glen Innes Eagles Basketball Trust. This charity, started by Ester, provides a safe place for community children to learn basketball and eat after school and during holidays.

We assisted with the preparation of the first set of annual reports which included discussion around key elements of the SSP statistics, submission of the first GST report and issues on creating invoices. We also assisted in fixing errors that had arisen in processing the bank transactions which resulted in the reconciliation not balancing.

"I am blown away by the dedication, time and knowledge the team, led by Glen Hill (ANCAD), have volunteered. Our particular issues of having high overhead costs catapulted us instantly into the realms of GST and business tax, IRD forms and scary, official-looking letters. From having no system, no way of accounting for grants and funds, we are now legitimately running our accounts in Xero. The IRD seems to be happy and we have data and reports to report back to our funders and donors. Thank you all." - Esther Ducai, Board Chair, GI Eagles Basketball Team.



Consultancy impact story Aotearoa NZ Breast Cancer **Community Trust**

Another organisation ANCAD had assisted was the Aotearoa NZ Breast Cancer Community Trust which provides safe and confidential online spaces for people who are, or have, suffered the disease and its often, debilitating effects. The Treasurer, Hazel Jennings, sought assistance in preparing the first annual reports submitted to the Charities Commission. She had done a good job in preparing the document but sought clarity in certain technical areas and the confidence given by an overview of the submission.

Consultancy impact story **Good Works Trust**

ANCAD has had connections with the Good Works Trust, on the North Shore, for some time. The Good Works Trust played a pivotal role in the launch of ANCAD's Food Insecurity Report, in August 2023 and contributed to the establishment of the local Food Insecurity Network (we have showcased their organisation in previous issues of ANCAD's Community Voices magazine, formerly known as Community

The Good Works Trust food bank provides crisis and emergency food parcels across the North Shore, by referral from agencies and social workers. They support vulnerable and hard to reach whānau through several channels, including a mobile Social Supermarket, a school lunch kit programme,

delivering lunch supplies to seven schools on the North Shore, to distribute to families unable to provide lunches, and an annual pop-up Christmas Shop. The aim is to give people a 'hand up' rather than a hand out, by transitioning them from dependence on food parcels, into having control over their food supply - tino rangitiratanga thus improving mana and self-reliance.

ANCAD provided industry research on pay scales through our HR consultant and supported the organisation in their review of job descriptions and employment contracts.

Ask the Experts impact story Open and Connect NZ

Open and Connect NZ is a charity organisation dedicated to fostering the growth, well-being, and integration of migrant families in New Zealand. Our mission is to create an interactive and secure community that nurtures connections and empowerment through structured initiatives, engaging activities, and educational programmess.

This year, I had the opportunity to attend some training sessions organized by ANCAD's LiiFT Aotearoa. These included sessions on "Governance and Management" and "Funding." The "Governance and Management"



session clarified the distinctions between governance and management, a topic that had previously been unclear to me. I now have a better understanding of the roles of the board and its relationship with the management team.

The Funding Forum introduced various funders, and their presentations provided detailed information about their requirements. This insight has streamlined our funding application process, making it easier and faster to apply.

Additionally, I attended one of the "Ask the Experts" sessions and received valuable advice on managing finances. A financial expert, Glen Hill, from ANCAD, explained how to use XERO more effectively and maintain accurate financial records. ANCAD also connected me with Stephanie Maitland, a funding expert and Lisa Easte, an HR expert, who provided mentoring support and answered my inquiries in person.

These training sessions and support from ANCAD have significantly contributed to the development of our organisation. The practical knowledge and expert guidance we received have enabled us to operate more efficiently and effectively.

Overall, ANCAD's support has been instrumental in our growth and success, empowering us to achieve our mission with greater confidence and competence.



COMMUNITY DEVELOPMENT & ENGAGEMENT

STRENGTHENING COMMUNITIES INITIATIVE

We played a supporting role in amplifying regional community voices through organising two community hui and a range of online discussions working with collaborative partners Catalyse and Community Waitakere. Inspiring Communities and a range of other key community leaders contributed to the success of this initiative. A co-designed action plan has been created from the hui and engaged funders are supporting these actions. We aim to pilot some activities mid-way through 2024-2025 with a view to providing resources, engagement and stakeholder engagement at the regional level.

WORKING WITH DIGITAL SENIORS

We worked with Digital Seniors, a national organisation providing digital literacy and access support, as a steering group member for 18 months and in short term contract delivery (Sep-Dec 2023) to support an interim stage of development of hubs on the Northshore, during a hiatus between appointments. We are delighted that our then Community Development Lead, Sarah Thorne was able to progress to a senior role at Digital Seniors, in early 2024. Digital Seniors is going from strength to strength as it expands its community hubs, collaborations and partnerships.

MARY THOMAS CENTRE: ACTIVATION CELEBRATING 436 EVENTS

The Mary Thomas Centre buzzed with activity in 2023. Hosting 436 events by 28 different groups and organisations, it truly embodies community spirit. ANCAD made the decision to end its activation of the Mary Thomas Centre in December 2023 with changing community use, the ageing fabric of the building and a review of community services facilities by the local board. Our published booklet "From Paddocks to Place" tells the story of the Mary Thomas Centre and is still available.



ANCAD's journey is one of resilience, community, and shared purpose. Thank you for being part of it. Together, we build a safer, more connected Auckland North. As we reflect on 2023 - 2024, we invite you to join us in building stronger, safer, and more connected communities. We thank all who contribute to our ongoing journey with our communities.

IMPACT WITH ETHNIC COMMUNITIES

Eva Chen (Ethnic Community Engagement Lead) came on board with the ANCAD team in March. Eva has a strong profile in her work with ethnic communities and we look forward to her contribution to ANCAD's mahi with community in the next twelve months. Eva is already actively engaged in a range of events and initiatives, sharing her connections and offering opportunities for ANCAD to provide capability resources to empower those groups.

BUILDING RESILIENCE: A 3-YEAR PILOT PROGRAMME

In June, ANCAD completed a transformative 3-year resilience programme. Our appreciation to all who participated in the many discussions and meetings, bringing a range of perspectives, values and experiences to the project. Heartfelt thanks go to our steering group members and to Greg Morgan, Gavin Gunston, and Trish Deans and the Devonport Peninsula Emergency Support Group for their experience, drive and support. Madison O'Dwyer, our community resilience coordinator for the project, deserves special mention. We were delighted that at the conclusion of this and other associated resilience work, Madison progressed to a senior advisor role in the parks and recreation team at Auckland Council.

LEARNING FROM CYCLONES AND FLOODS

The cyclone and flood response of 2023 taught us valuable lessons. Local and national reports led to shifts in approach with a more joined-up strategy and increased resource. ANCAD's submissions and feedback continue to shape resilience efforts.


RESILIENT AUCKLAND NORTH WEBSITE

LONG TERM PLAN CONSULTATION (LTP)

Engaging with Pacific, youth, and ethnic communities, we received 89 specific submissions to contribute to the Auckland Council Long Term Plan consultation. But it wasn't just about numbers - it was about amplifying voices and promoting community partnerships and strengthening relationships and dialogue. We thank the Auckland Council Community Partnerships team for the opportunity to work with them on this initiative. The feedback from the submissions informs long term operational and strategic planning for Auckland Council and affected communities.

SENIORS HUI ON The North Shore

Our hosting and event management of the seniors' gathering was more than just a one-day event; they were moments of connection, reflection and learning for the partnering organisations and attendees. They tell the story of wisdom, resilience, and shared experiences. This event resulted in agencies working with Seniors having first hand feedback on areas of need and resource and allowed for networking and collaboration between organisations. We thank Auckland University, Age Concern, CMA and the Positive Ageing Centre for their collaboration and expert participation.



ACTIVE AGEING EXPO

Collaborating with Heart of the Bays, we delivered an expo that celebrated active living and wellness for older adults. The event, attended by over 40 expo partners and many members of the public, captured the vitality and community spirit of older adults in our communities.

BETTER CONVERSATIONS

Our partnership with Onewa Christian Community sparked meaningful dialogues. Conversations matter, and they shape our community's future. The lens of restorative justice applications to community conversations is a valuable tool.

NORTH SHORE FAMILY VIOLENCE PREVENTION

FVRC (FAMILY VIOLENCE RESPONSE COORDINATION)

Ways we have contributed to a 'joined-up' approach to respond to family violence.

Ongoing North Shore NGO representation at the Te Ohu Kitenga Waitemata Wellbeing Group (regional governance group) meetings. Our North Shore Wellbeing Leadership Group complements Te Ohu Kitenga with a place-based North Shore focus.

Effort continues to be directed towards the coordination and facilitation of the quarterly Waitemata Wellbeing ICR Forums.

Continued active participation in the implementation of Te Aorerekura – The National Strategy and Action Plan to Eliminate Family Violence and Sexual Violence: https://violencefree.govt.nz/national-strategy/.

The NSFVPN Coordinator continues to represent the Network at the monthly SWG (System Working Group) forums. These are national hui coordinated by Te Puna Aonui. Through this forum we will work with MSD and Te Puna Aonui to align with Te Aorerekura opportunities.

Ongoing coordination and development of the Safer Whānau integrated community response programme. A key focus area is the development of our community-led multisector case management forum, procedures and protocols for this and our strategic level steering group.



SAFER WHĀNAU

The Safer Whānau project is an interagency partnered response to family violence on Auckland's North Shore. This innovative service involves working collaboratively with key social service providers to provide a wrap-around holistic whānau centred service. Whānau, now more than ever, present with multiple issues as economic pressures compound whānau stresses and difficulties. Families referred to family violence services often require the involvement of Work and Income, Police, Health, Oranga Tamariki, Ministry of Justice and multiple community agencies to effectively address all

their needs.

Our Safer Whānau multi-sector case management forum initially convened in March 2023, bringing together our PBI partners to codesign what is to be a community-led forum. Consultation with our North Shore Wellbeing Leadership Group supported our first multi-sector forum to come together with government and community representatives in April 2023.

We place tamariki and rangatahi at the centre and wrap whānau-focused support and collaboration around them, with MSD-funded whānau plans.

As you know Gregg and I regularly attend your monthly meetings... and personally I have been impressed with the way you engage with a variety of groups within our community to address youth issues within our local board area...I was really pleased so many of the youth group were there in person today. BAYS IN ACTION

Description of the ways in which we have helped build local leadership for the primary prevention of family violence. Primary prevention refers to actions to stop violence in the first place.

Safe Space Initiative: In February 2024 we developed a proposal for the DTLB outlining the reestablishment of a (refined) Safe Space in the Takapuna Library. The East Coast Bays Library are also keen for a Safe Space in Browns Bay.

Partnering with Neighbours Aotearoa and Neighbourhood Support: Exploration of strategic opportunities to collaborate on initiatives and events.

Bays Youth Hub: We continue to explore a multi-purpose community venue with the Barracudas Rugby League club (and new interested parties: Judo club / Restore Hibiscus and Bays).

Youth Wellbeing and Education outcomes: There are a number of initiatives BiA (Bays in Action) would like to explore further in 2024: Cultural opportunities; Education outside the classroom – internships and work experience with local businesses, alternative education opportunities, wellbeing and parenting programmes in the community. All this planning includes an overarching youth development focus through the Bays Youth Voice initiative.

Bays Youth Voice Development: We collectively will explore funding opportunities to build the capacity of the emerging Bays Youth Voice facilitation role to have a broader Youth Development Coordination kaupapa. Heart for Youth Trust will act as fundholder and contractor for this mahi moving forward.

Bays Youth Internship Programme: An initiative connecting youth with volunteering opportunities with our local community organisations and associated projects and initiatives.

The Bays in Action Think Tank is our signature project for primary prevention initiatives and activities.



TREASURER'S REPORT



This is my second year as Treasurer, and I am pleased to present the ANCAD accounts for the financial year ending 31 March 2024.

Included in this Report are the Financials for 2024.

The auditor is REB Chartered Accountants, based in Albany and they have approved the presented accounts. Given the full accounts are not included in the Annual Report please note they are available to those who wish to review a copy, and will be available on the Charities Services website soon.

ANCAD has faced considerable financial challenges during the years and the team has diversified its funding streams in keeping with these challenging economic times. The not-for-profit sector is a highly competitive environment where we seek to attract the necessary operating income needed to maintain the important services we provide to our community.

Over the year our team has developed and built strategic

relationships with our valued funders. These initiatives have stabilised this financial year's income sources as well as shaping our medium-term prospects. As those reading my report will appreciate such work demands are challenging accordingly, I wish to acknowledge and thank the staff for their outstanding efforts.

During the year both our board and the finance committee have worked diligently shaping the budget and forecasting models whilst maintaining prudent financial management. For example, we implemented a programme to invest savings on term deposits thus increasing returns, whilst maintaining smaller monthly deposits to maintain cash-flow flexibility.

I wish to acknowledge the excellent bookkeeping disciplines by the ANCAD staff as well as our external contracted skills. During the year we saw a reduction in staff numbers of two and a shift of some roles from salary to contracts.

Our revenue for the financial year to 31 March 2024 was


\$923,935 includes an amount of \$114,550 for grants and contracts completed in prior years, but remaining funds are being reserved to continue the community services intended. The current spend of \$809,385 represents an 11.7% decrease from 2023. Central Government remains our largest contributor representing 22.0% which was a 6.0% decline on last year's result.


Expenditure was mostly projectrelated and for the financial year to 31 March 2024 was \$791,917 representing a 10.3% decrease from 2023

Being a repeat of last year's sentiment, the coming financial year will be far more challenging with the board remaining close with our ANCAD staff.

In conclusion it has been a satisfactory year for ANCAD with the financial position of the organisation sound for the 2025 financial year.


